

2015 IPHA General Membership Meeting
October 3, 2015
Gordyville

General membership meeting was called to order at 6:11 p.m. by IPHA President Steve Morse.

Motion made by Shelly Prehoda to accept the January 2015 General Membership meetings as posted on the website. Fred Cole seconded motion. All in favor, none opposed. Minutes approved.

Discussion ensued about **2016** IPHA Show Schedule:

- 4/16 & 4/17 – POR Gordyville (POR) – Confirmed & application submitted to APHA **(4 Judge)**
- 5/21 & 5/22 – Gordyville. Options for show is to:
 - partner with IN, or
 - IL POR Only, or
 - 1 day/2 judge show, or
 - 2 one day/2 judge show

Motion made by Carl to take the May 21 & May 22 slot at Gordyville and make it a 2 judge/2 day show & combine age groups. Motion seconded by Brandy Daugherty. All in favor, none opposed. Motion passes.

- *6/18 - Mark Merriman's Show at Clinton, IL @ DeWitt County Fairgrounds **(1 Day/1 Judge)**
- 6/25 – Belvidere **(1Day/2 Judge)** – Confirmed & application submitted to APHA
- July State Fair
- *7/30 – Mark Merriman's Show at Clinton, IL @ DeWitt County Fairgrounds **(1 Day & 1 Judge)**
- 8/13 – Hopedale **(1 Day & 2 Judge)** Confirmed & application submitted to APHA
- 9/3 & 9/4 - Labor Day at Gordyville **(2 Day & 2 Judge)**. Also potential to host Premier Paint Sire show as they reached out to us, but haven't returned our calls.

* Mark needs to confirm the dates with the DeWitt County Fairgrounds & will let us know.

Membership also discussed partnering with Indiana on the May or September show. Pauli Crull from the Indiana club was present and said that they have shows scheduled at Cloverdale in May so if they were to partner with IL it would make it three weeks in a row for shows at Cloverdale for them. She said the May date was doubtful for partnership & she would have to go back to her membership to discuss further dates at this point and was not able to commit.

Mark Merriman made a motion to go with 2 day/2 judge show on 9/3 & 9/4 at Gordyville without shortening show bill. Mark Jackson seconded the motion. Motion was defeated by membership.

- 9/3 & 9/4 Labor Day Show at Gordyville: Pat Ross made another motion to have a 2 day/2 judge show & combine age groups which would be the same format as voted and approved by membership for the May 21 & May 22 show. For example, Youth classes will be combined, Amateur combined, Solid Paint Bred will be combined. Open classes will still be separate as they are today at the Show Manager's discretion.

However, for those classes that are combined for example, Youth, when tracking Illinois High Points for year-end awards, they will be split out by age group, which is what occurs today when combined. Carl Wilcox seconded the motion, all in favor, none opposed. Motion carries. Discussion about starting the 9/4 show at 9:00 and it was decided it will be left at 8.

- 9/10 & 9/11 – Cloverdale IN – Paint Partners was replaced with the Labor Day show 9/3, 9/4 at Gordyville.
- 10/1 & 10/2 – POR Futurity:

Motion made to adjourn meeting at 6:43 p.m., seconded by Carl motion carries. Meeting adjourned at 6:43 p.m.
