- 1. Financials Jerry Wyrick discussed the 2015 show season financials. First show at Gordyville made \$16,216. Futurity made \$12,300, and rest of shows made between 2,000 to \$3,000. Overall, we made almost \$40,000.
- Income & Expense Report Everything is listed for the year. Account balances are as of 1/1/2016:
  - o Futurity \$15,017.17 (also have a CD for \$16,000),
  - o General \$26,360
  - o Youth \$7.478

    - New Kingdom based out of the Quad Cities and have been around since 1984. They handle 80-100 students with physical and/or emotional disabilities. They are accredited through PAC.
    - Central Illinois Riding Therapy (CIRT) service Youth & Adult (also wounded warriors).
  - o CIRT was decision based on membership vote.
  - Human foundations:
    - St. Jude who treat children with cancer without any charge to the family.
    - American Diabetes Foundation
  - o St. Jude was decision based on membership vote.

  - If you do every test on a foal it costs \$420. Went back to APHA to re-write the rule in a different way. Make it not mandatory to DNA test.
