## SHOW CLASS INFORMATION

- If foal is the result of a purchased breeding from the Illinois Paint Breeders Futurity Stallion Service Auction, and was declared/nominated by Aug 15th of weanling year, all entry fees through 3 year- old performance classes will be paid at the ½ entry fee.
- All others will be paid at stated amount.
- For foals being shown their weanling year, this entry form serves as a declaration/nomination of that eligibility.

## \*LIMITED NON-PRO DIVISIONS FOR WEANLINGS AND LONGE LINE

- Only those horses sired by a stallion selling in the stallion service auction, or who have met admissibility requirements by paying their way in (individually) through the Alternative Entry program will be eligible to compete in these classes.
- No money will be grandfathered in to these classes from the IPHA Stallion Service Auction (SSA). Payback will exist of monies received from entry fees, minus 9% withheld for operations/awards and advertising expenses.

**New as of 8.13.2020 and for 2020 ONLY...we understand what a challenging year it has been so far. In order to make it easier to show, we have changed the entry deadlines as follows:**

- ✓ **Entry form deadline has been extended from August 15, 2020 to September 25, 2020** due to the COVID pandemic. Forms postmarked after midnight September 25, 2020 will be considered late, and fees will be doubled.
- ✓ **Late entries will be now be accepted up until 5:00 pm CT, Friday, October 2, 2020 (night before the show).**
- ✓ **Alternative Entry program nomination fee has removed the wording of ½ of current advertised stud fee or \$250, and instead will require a flat fee of \$250 plus applicable class entry fee(s) or class late entry fee(s) subject to postmark date.**
