Purse Distribution:

Fees minus 9% will be added to the class the horse entered and will be considered money in and money out with no contributions from the proceeds of the Stallion Service Auction (SSA)/Stallion Service Sale (SSS).

Below is for *illustrational purposes only* and utilizes a Yearling entry since the maximum available classes to enter is four. 91% of nomination and fees paid will be added to a class based on the number of classes the horse is entered in, for example:

1 Class	91% added to one class
2 Classes	45.5% added to each class
3 Classes	30.33% added to all three classes
4 Classes	22.75% added to all four classes

All payback will be divided on the following percentages based on the number of horses entered in each respective class:
