The Alternative Entry Program will also remove the language pertaining to ½ of the advertised stallion fee, and instead the nomination fee will be a flat fee of \$250. **The above changes only apply to 2020**.

SHOW CLASS INFORMATION

For foals of stallions whose services were not sold through the Illinois Paint Horse Association Stallion Service Auction:

- In instances where a stallion was nominated and did not sell, or was not nominated at all, foals by those stallions may become eligible to show on an individual basis under a hardship clause.
- Upon payment of a nomination fee of:
 - As of 8.13.20 Nomination fee will be a flat fee of \$250, the office fee of \$25 and the normal class entry fee; the foal will be eligible to compete in their corresponding age classes, and may compete in classes in subsequent years with payment of the normal class entry fees.
- No other foals by that stallion will be eligible to show unless their owners make the previously-noted payment for each foal.

Entry deadline has been extended from AUGUST 15th to September 25th, 2020 at normal fees. LATE DEADLINE: Entries postmarked after midnight September 25th will be considered late, and class entry fees will be doubled. Late entries will be accepted until Friday, October 2nd, 2020 at 5 pm CT (night before the show).
